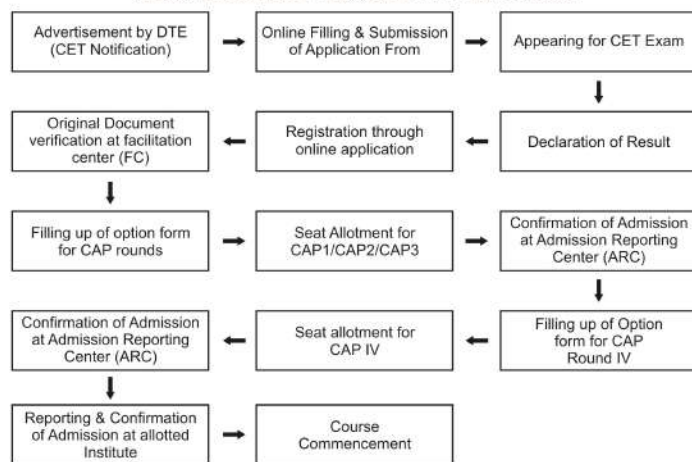


MBA ADMISSION PROCESS FLOW CHART

MH-CET GENERAL INSTRUCTIONS.

- 1) There shall be 200 multiple choice objectives type questions. (MCQ's)
- 2) The Question paper for the CET will be set in English only. Translations in any languages will not be available.
- 3) The CET would be of 2 & 1/2 (Two & Half) hour's duration and would have a maximum of 200 marks.
- 4) The CET would not have negative marking.
- 5) The marks at the CET would be considered for a admission during the current academic year only and would not be allowed to be carried to the next year.

ELIGIBILITY :

A) Bachelor's Degree with minimum 50% in Case of Open Category & minimum 45% in case of physically handicap belonging to maharashtra state only. minimum 45% in case of Reserved Category students or Appeared for final year exam of bachelor's degree.
